1. Holder of the rights for the generators is SEALAND TRADE CORPORATION INTERNATIONAL (STCI), UStID Number: DE164906133.
2. The Club membership fee and the user fee for the device are valid – **without further cost** – for the contract period of five years. After five years an application may be made to purchase the generator for € 100 as property.
3. Together with the application a handling fee of € 50 shall be sent to the account of the SEALAND TRADE CORPORATION SCHWEIZ AG:

4. The interested party I given the option to test personally several generators with a representative of the STCI as to their effectiveness and then chose one that seems suitable. Alternatively the generator may be sent by DHL with shipment number.
5. The remaining € 950 are to be paid in cash when the generator is handed over, if the option for shipment is chosen, it must be paid in advance into the above account.
6. The user may use the device without restrictions. The rights for usage are not transferrable.
7. The STCI does not guarantee the effectiveness. Any liability by the STCI for any supposed or implicit effects of a physical, biologic, psychological or mental kind is excluded. The user acts under his personal responsibility.
8. The user shall refrain from any derogatory remarks concerning the device, its effects or the VRIL energy in general towards third parties.

9. The user is asked to submit a report in which he outlines personal observations in the physical, biologic, psychic or mental areas, this is however voluntary. He accepts that the interconnection of his observation to the traditional physical worldview is not necessarily given. The reports may be published on the website of the Principality of Sealand anonymously.
10. For important reasons the contract may be cancelled by the STCI before the end of the contract period.
11. Place of jurisdiction and execution is in CH-8340 Hinwil, Switzerland.
